- Local Government cannot change the nomenclature / cadre OR convert the post.
- Recruitment / induction on vacant post shall be made after making advertisement through office of the DGPR and observance of criteria, merit and codal formalities subject to approval of Govt. & availability of own source revenue.
- 5. In case an employee / Official / Officer of any other Department like Public Health Engineering / PHATA / LG&CD etc is repatriated to his parent Department, the post held by him shall stand deleted automatically from the schedule of establishment of respective local government.
- In future it will be treated as misconduct on part of appointing authority, if anyone is hired / employed on work charge / daily wager basis under any circumstance OR on any pretext.
